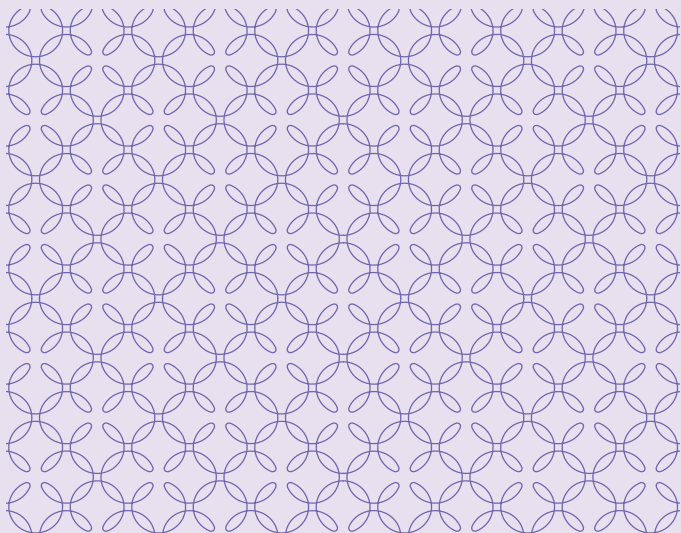

Waa maxay addoonsiga casriga ah?

Addoonsiga casriga ahi waxa uu yimaadaa marka qof uu qof kale ula dhaqmo sidii in uu isagu leeyahay – isaga oo xaddidaya xorriyadiisa. Addoonsiga casriga ahi waa erey daboolaya dambiyo sharci oo kala duwan. Kuwaas waxaa ka mid ah:

- Addoonsiga
- Adeeg
- Adeegga galmada
- Shaqalaaha qasabka ah
- Guur qasab ah
- Addoonsiga deynta
- Ka ganacsiga dadka
- Shaqaalaysiinta khiyaanada leh ee shaqada ama adeegyada
- Ka ganacsiga xubnaha iyo unugyada
- Ka faa'iidaysiga galmada ee carruurta ee internetka

Ma ka jira addoonsi casri ah NSW?

Haa Waxaa jira dad lagu qiyaaso 50 milyan oo ku nool adduunka addoonsiga casriga ah. Qiyaastii 41,000 oo qof ayaa ku nool Australia addoonsiga casriga ah, iyadoo lagu qiyaasay 16,400 oo ku nool New South Wales.

Waa maxay qaar ka mid ah tusaalooyinka addoonsiga casriga ah ee NSW?

Xafiiska Guddoomiyaha Ka-hortagga addoonsiga ayaa helay warbixino la isku halleyn karo oo ku saabsan noocyo badan oo kala duwan oo addoonsiga casriga ah ee NSW, oo ay ku jiraan:

- Shaqaale ku xayiran shaqada khasabka ah ee beeraha gobolka NSW.
- Shaqaalihii lagu khasbay inay u adeegaan guryaha magaalooyinka.
- Haweenka iyo carruurta, la qurxiyay oo lagu khasbay ka faa'iidaysiga galmada, qof ahaan iyo iyada oo loo marayo baraha warbaahinta bulshada.
- Nadiifiyeyaal iyo waardiyayaal ka shaqeeya baloogyada xafiisyada, oo lagu haysto gacanta addoonsiga deynta.
- Dhalinyaro rag, dumar iyo gabdho lagu khasbay inay guursadaan halkan ama dibadda.
- Dadka naafada ah ee lagu isticmaalo goobaha shaqada ee kala soocida ama daryeelka hay'adaha.
- Ku shaqeysiga khasabka ah iyo ku shaqeysiga carruurta ee khasabka ah ee dadyowga Qaramada Midoobay.

WARQADA XAQIIQADA NSW Gudoomiyaha Ka Hortagga Addoonsiga (NSW Anti-slavery Commissioner)

Muxuu sameynayaa Gudoomiyaha Ka-hortagga addoonsiga si uu u joojiyo addoonsiga casriga ah ee NSW?

Gudoomiyaha ka hortagga addoonsiga waa:

Dhisidda awoodda ka-hortagga -la shaqaynta dawladda NSW iyo hay'adaha aan dawlaga ahayn si looga caawiyo inay aqoonsadaan dadka u nugul addoonsiga casriga ah iyo ka hortagga dhibbanaha. Tani waxay ku lug leedahay qalabaynta shaqaalaha safka hore iyo samaynta taageero wax ku ool ah iyo khadka gudbinta.

Awood-siinta daaweynta -la shaqaynta bixiyeyaasha adeegga si loo hagaajiyo helitaanka dadka khibradda u leh addoonsiga casriga ah si loo helo daweyn waxtar leh. Tan waxaa ka mid ah xoojinta helitaanka taageero wax ku ool ah iyo kobcinta hoggaanka badbaadayaasha.

Kobcinta dhaqamada ganacsi ee mas'uulka ah -la shaqaynta dawladda iyo shirkadaha gaarka loo leeyahay si ay u muujiyaan hoggaaminta aqoonsiga iyo wax ka qabashada addoonsiga casriga ah ee supply-chains (silsiladaha sahayda) iyo maalgashiga. Tan waxaa ka mid ah ka saarida alaabada addoonsiga casriga ah ee iibka dadweynaha iyo kobcinta dhaqamada ganacsi ee mas'uulka ka ah qaybta gaarka loo leeyahay.

Beddelka sheeko -kor u qaadista wacyiga ku saabsan addoonsiga casriga ah ee NSW oo dhan si hab awood u siiya badbaadayaasha oo u dhista ganacsiga iyo kiisaska siyaasada ee ka hortagga addoonsiga.

Horumarinta bulsho ujeedo leh -dhigista aasaaska waara oo loo dhan yahay fulinta Xeerka Addoonsiga Casriga ah 2018 (NSW), isu keenista daneeyayaasha si wada jir ah uga shaqeeyaan ujeedooyinka sharciga iyo hubinta in dadaalka lagula dagaalamayo addoonsiga casriga ah uu noqon karo mid waara oo lagu guuleysto.
