#### **Online Filing**

Online filing commenced on 15 May 2023.

The uptake of the online filing by legal practitioners has a been a great success. In 2024, 5,289 documents have been filed online, representing 83% of all documents filed (an increase of 7% from 2023).



The total number of claims filed in 2024 (652 claims) decreased by 2.5% from 2023 (669 claims).

The total number of claims finalised in 2023 (558 claims) decreased by 12% from 2023 (633 claims).





## Yearly comparison (10 year trend)








