

## FACS statistics quarterly report summary

This accessible text document provides an overview of Family and Community Services (FACS) child protection services quarterly data. It accompanies the [interactive dashboard](#), published on the FACS website.

### July – September 2017 quarterly overview

Services to children and young people data are grouped into three main themes:

1. **Responding to child and young person concern reports** – data on mandatory reporters and concern reports made to the NSW Child Protection Helpline.
2. **Stable and nurturing environments for children and young people** – data related to out-of-home care (OoHC) placements, guardianship orders, placement of Aboriginal children and young people with extended family.
3. **Keeping children and young people safe** – data related to children and young people exiting OoHC, children and young people in statutory OoHC, OoHC placement types, and the age of children and young people entering OoHC.

#### 1. Responding to child and young person concern reports

- **FACS' Helpline** received 32,557 contacts in the quarter. This is equal to a drop of 4.1 per cent from the last quarter. Compared to the same quarter last year, the drop is 0.5 per cent.
- These contacts equated to 70,931 **child and young person concern reports** for this quarter.

- **Mandatory reporters** accounted for 80.3 per cent or 56,970 of all concern reports in this quarter.
- The number of **children and young people involved in concern reports** was 42,302 in the quarter. This is equal to a decrease of 1.0 per cent from the last quarter. Compared to the same quarter last year of 41,108 children and young people, there was an increase of 2.9 per cent.
- The number of **Risk of Significant Harm (ROSH) reports** was 40,749 in the quarter. This is equal to an increase of 1.9 per cent from the last quarter. Compared to the same quarter last year of 37,208 ROSH reports, there was an increase of 9.5 per cent.
- For all **ROSH reports**, 22.7 per cent or 9,268 were classified as requiring a response in less than 24 hours, 36.2 per cent or 14,761 were classified as requiring a response in less than 72 hours, and 38.6 per cent or 15,730 were classified as requiring a response in less than 10 days.
- The number of children and young people involved in **ROSH reports** was 29,738 in the quarter. This is equal to an increase of 1.0 per cent from the last quarter. Compared to the same quarter last year of 27,569 children and young people, there was an increase of 7.9 per cent.

## 2. Stable and nurturing environments for children and young people

- The total number of **children and young people in OoHC with fewer than three placements** were 11,401 at the quarter end. This is equal to a decrease of 2.4 per cent or 284 children and young people from the end of the last quarter. Compared to the same quarter end last year of 12,020 children and young people, there was a decrease of 619 children and young people or 5.1 per cent.
- The total number of **children and young people on guardianship orders** was 2,729 at the quarter end. This is equal to an increase of 2.5 per cent or 66 children and young people from the end of the last quarter. Compared to the same quarter end last year of 2,512 children and young

people, there was an increase of 217 children and young people on guardianship orders or 8.6 per cent.

- For 2,729 children and young people on guardianship orders as at 30 September 2017, 33.4 per cent or 911 were Aboriginal.
- 74.4 per cent of Aboriginal children and young people were placed with an Aboriginal carer as at 30 September 2017.

### 3. Keeping children and young people safe

- The number of **children and young people entering OoHC** was 566 in the quarter. This is equal to a decrease of 11.4 per cent or 73 children from the last quarter. Compared to the same quarter last year of 913 children and young people entering care, the decrease was 38 per cent or 347 children and young people.
- The number of **children and young people exiting OoHC** was 748 in the quarter. This is equal to an increase of 2.2 per cent from the last quarter. Compared to the same quarter last year of 667 children exiting OoHC, the increase was 12.1 per cent.
- The number of **children and young people in statutory OoHC** was 14,891 as at 30 September 2017. Of these 14,891 children, 38.8 per cent were Aboriginal.
- The total number of children and young people in OoHC (which includes statutory plus other) was 17,624 as at 30 September 2017. This is equal to a decrease of 6.9 per cent from the same quarter end last year of 18,924. Of those 17,624 children in OoHC, 51.7 per cent were in relative or Aboriginal kinship care, 43.5 per cent were in foster care, 3.5 per cent were in residential care, and 1.3 per cent had other care arrangements.
