	Two forms of identification at least one of which includes your signature. Examples of identity documents include; driver licence, Medicare card, passport, birth certificate, health care or pension card and student card.
	Evidence of change of name, if applicable. If you have changed your name please provide either; marriage certificate, change of name certificate or a statutory declaration explaining why you cannot provide documents showing your change of name and how you did this.
	You are encouraged to leave a message to help anyone applying for information to understand why you have placed this contact veto. If you want to leave a message to be passed on, please attach a message/letter to this application.

If the adoption occurred in another state, you must apply to that state to place a veto, even if the adopted person was born in NSW.
