GRS Resource: Quick reference document for GSF agencies

December 2023

This quick reference document has been created to help Government Sector Finance agencies understand their requirements under the NSW Anti-slavery Commissioner's *Guidance on Reasonable Steps to Manage Modern Slavery Risks in Operations and Supply-Chains* (*Guidance or GRS*).

Risk management should focus on risk to people. Reporting obligations depend on the risk level, your agency's capability level and value of the procurement.

Reasonable steps

Since 1 July 2022, agencies have had a legal obligation to take reasonable steps to ensure that goods and services procured by or for them are not the product of modern slavery.

There are 7 Reasonable Steps in the *Guidance*, which are designed to help agencies discharge this legal obligation:



For each of these Reasonable Steps, the *Guidance* provides practical advice on what steps agencies can take to identify and mitigate modern slavery risks in their operations and supply chains.

Some key actions required at the organisational level under the first Reasonable Step 'Commit' are below. Agencies can also refer to the summary of Reasonable Steps and annual reporting expectations under the *Guidance* here for further information.

The NSW Anti-slavery Commissioner also publishes other 'GRS Resources' to help agencies meet their obligations. These are available on the Commissioner's website <u>here</u>.

Organisational steps to 'Commit'

Modern Slavery Risk Assessment

Agencies should conduct a Salient Modern Slavery Risk Assessment of their supply chain. The concept of 'salience', and how to conduct a Salient Modern Slavery Risk Assessment, is defined in the *Guidance* (see Part 1.2).

Agencies can use the **Commissioner's Inherent Risk Identification Tool** to assist with this process and ensure they are assessing risk in a reasonable manner.

'Inherent modern slavery risk' is the level of salient modern slavery risk exposure associated with a particular product category, in the absence of risk controls or effective mitigation.

This risk analysis will provide the basis for decisions about what targeted actions are needed to address modern slavery, and to identify key stakeholders, such as key buyers and suppliers.

Modern Slavery Policy

Agencies must have a Modern Slavery Policy by 30 June 2024 that has been signed off by the Head of the Agency or Department.

The Policy should include:

- high-level targets for addressing salient modern slavery risks,
- o how risks will be assessed, prevented, mitigated, remedied and reported, and
- o how the agency will evaluate their progress.

Agencies should engage key stakeholders to develop this policy, focusing on those most impacted by priority risks. This includes internal stakeholders broader than procurement, such as HR and legal, and external stakeholders such as key suppliers and supply-chain workforce.

Modern Slavery Risk Management Plan

Agencies must develop a risk management plan to operationalise the commitments made in the Modern Slavery Policy (see GRS Reasonable Step 1.4 for further guidance).

The plan should provide for:

- assigning accountability for senior leadership to deliver SMART goals against the plan,
- o tracking progress and reviewing at least annually, and
- o making clear that risk management efforts are prioritised based on risk to people.

Reporting

Annual reporting

Agencies must report annually in their annual report on the steps they are taking to ensure the goods and services they are procuring or procured for them are not products of modern slavery.

Agencies should report in two places:

- 1. By including relevant information in their agency's formal annual report.
 - Agencies can refer to TPG23-10 Annual Reporting Requirements | NSW Treasury for further information on annual reporting requirements.
 - The Office of the Anti-slavery Commissioner provides an Annual Reporting Template to assist this process.

- 2. Using the online GRS Annual Reporting Form.
 - The GRS Annual Reporting Form is an online form which allows covered entities to share data directly with the Office of the Anti-slavery Commissioner.
 - Agencies should complete and submit this form upon publishing their Annual Report.

Heightened Modern Slavery Due Diligence reporting

Starting 1 July 2024, agencies must report within 45 days after a contract becomes effective when that contract: commences on or after 1 July 2024, is valued at \$150,000.00 (including GST) or more, and requires 'Heightened modern slavery due diligence'.

Agencies should determine which procurements require heightened modern slavery due diligence by using the Guidance and related resources available on the website of the NSW Anti-slavery Commissioner.

When buying

Applying the right level of due diligence to your procurement

Agencies must apply the level of diligence due (i.e. 'required') for a particular procurement process. This is determined by two factors: 1. The inherent risk of procuring that kind of good or service or construction activity; 2. The capability level of the agency.

Agencies should use the Commissioner's Inherent Risk Identification Tool to determine the risk level of each procurement.

The Commissioner's Guidance also provides instructions on determining an agency's capability level.

For heightened modern slavery due diligence procurements, there are three additional expectations:

- o use of 'Heightened' model tender schedules in procurement processes,
- o use of 'Heightened' model contract clauses in contracts, and
- transaction level reporting

Figure 1. How to determine the level of due diligence to apply




Figure 2. How to determine Agency capability level

Model tender schedules and contract clauses

Agencies are encouraged to use the model tender schedules and contract clauses provided in Appendixes I and J to the Commissioner's Guidance in their procurements.

Agencies involved in heightened modern slavery due diligence procurements must use the 'Heightened' Model Tender and/or Contract Clauses provided in the Guidance.

The Guidance also provides 'Streamlined' Model Tender Clauses and Model Contract Clauses. These are a resource that can be used in Minimal, Low and Standard Modern Slavery Due Diligence processes – that is, all except Heightened.

These Model Clauses may be adapted based on the agency's needs, but must continue to adhere to the 'shared responsibility' risk management approach set out in the Commissioner's Guidance.

Agencies must report annually on their sourcing activities, and should include information about their use of these clauses in procurements at all GRS Due Diligence Levels.

Throughout the contract term

Monitoring and evaluating supplier performance

Agencies must monitor suppliers' modern slavery performance throughout the duration of the contract to ensure compliance with expectations and manage emerging risks.

Agencies should describe in their Modern Slavery Risk Management Plan how they will monitor and evaluate performance.

Periodic audits and other ongoing supplier and worksite assessments and evaluations will be critical to effective ongoing due diligence and contract management. Agencies must report on whether during the reporting period any Tier 1 suppliers underwent an audit addressing modern slavery risks.

Agencies can use other tools for monitoring performance including supplier self-assessment questionnaires (SSAQs), KPIs, worker voice mechanisms, workers surveys, engagement with unions and worker organisations, and digital tools.

Where appropriate and subject to resources, agencies should also seek to develop suppliers' capabilities around modern slavery. Agencies may do this through using collective leverage (working with other public or private buyers) and collaborating with relevant stakeholders, peers and experts.

Remedying risks or incidents of modern slavery

Agencies must provide or enable access to effective grievance mechanisms. Agencies do not necessarily have to administer their own independent mechanisms, but should look for opportunities to resource and manage mechanisms collaboratively where appropriate. Agencies should keep a record of complaints or inquiries made to grievance mechanisms relevant to modern slavery.

Where an agency identifies clear indicators of modern slavery in its operations or supply chain, it must take immediate steps to remedy these harms. The Guidance provides information on how to do this safely.

Agencies should only withdraw from relationships where a supplier or other business partner is unable or unwilling to effectively address modern slavery risks or concerns. The Guidance provides information on how to do this responsibly.

Agencies should use their leverage to address deficient supplier practices, e.g. through a Remediation Plan (as provided for in the Model Contract Clauses).

Agencies should keep a record of:

- o complaints or inquiries made to grievance mechanisms relevant to modern slavery.
- o any material breaches related to modern slavery which have been formally notified to suppliers.
- o any contracts or arrangements terminated on modern slavery grounds.

The Guidance provides further information on what data agencies must collect and report.

Summary of Reasonable Steps and reporting expectations under GRS

The table below summarises the actions expected of agencies for all procurement activities, and details the related annual reporting obligations.

There are **additional, separate expectations** for agency actions and reporting where they are involved in Heightened modern slavery due diligence procurements. See <u>here</u>.

Where a question asks for a percentage response, agencies should calculate this based on the <u>total</u> number of procurement activities or suppliers they are aware of in the reporting period, whatever the value of the procurement or its GRS Due Diligence Level.

Procurements involving Heightened modern slavery due diligence

For procurements involving Heightened modern slavery due diligence, there are three requirements that differ from all other procurement processes (i.e. those involving Minimal, Light and Standard modern slavery due diligence):
