### MYP grants session #2 Questions | Wednesday, 5 February 2025

### Q: Are organisations that are incorporated by an Act of Parliament eligible for this grant?

A: Yes. Not-for-profit organisations will be considered eligible, if they are NSW non-government organisations established under their own Act of Parliament

### Q: Can you submit an application as a lead, and a separate application as a subcontractor?

A: Yes. There is no limit to how many times you can apply for this grant opportunity as a subcontractor, but an organisation can only submit one application as the primary applicant.

#### Q: Can proposed budgets include a management/admin fee?

A: Yes, but these fees must be linked to the primary prevention project.

# Q: Is there a preference for collaboration across local governments areas, or collaboration that is place based i.e. services within a local government area?

A: No.

## Q: Can a national organisation not based in NSW partner with a NSW-based organisation who will be the lead?

A: Yes. However, the NSW based organisation must be registered in NSW and be the lead applicant.

## Q: If an application can demonstrate that they can achieve project outcomes within 2 years (total funding of 500K) would this be considered by DCJ?

A: No. This grant program is for a multi-year partnership over 3 years (June 2025-June 2028).

### Q: How do we find out if our charity is registered on NSW Fair Trading?

A: That registration information should be held by your organisation. If you are unsure, you can refer to this website: <u>https://www.fairtrading.nsw.gov.au/associations-and-co-operatives</u>

## Q: Are organisations that are not Incorporated Associations but Companies Limited by Guarantee registered with ASIC and ACNC eligible for this grant?

A: The link to check this is in the application EOI form in SmartyGrants https://abr.business.gov.au/Search/ResultsAll?SearchText=nsw+fair+trading

### Q: Do we need an external auditor for the final acquittal?

A: No.

### Q: Can national organisations apply? We are based in VIC but deliver our services in NSW

A: Only organisations registered in NSW are eligible for this grant opportunity.

### Q: How many projects will be funded by this grant?

A: There is no set number. It will be up to the Panel to determine the number of successful projects, within the overall funding limit for the grants.

#### Q: Can we apply to expand a program that may be funded beyond July?

A: Yes. As long as it's clear which activity is being funded by which funding and there is no 'double-dipping' for the same project.

#### Q: How much documentation do we need to provide to prove our partnership is genuine?

A: We recommend providing some form of document to demonstrate that you've planned this program together. The Guidelines and the EOI Form do not prescribe the format of the document – we do not require any formal MOU at the EOI stage.

### Q: How do we measure community-level change in our application?

We will accept organisational-level information collected on-the-ground. We recommend including a plan for monitoring and evaluating outcomes within your application.

#### Q: Is the purpose of this grant to replace core funding, or to scale up existing work?

A: The MYP Grant Program will focus on supporting existing community-based primary prevention programs that have demonstrated promise but are facing funding cliffs or challenges in expanding and scaling their delivery. This grant program is not limited to funding only those projects that are expanding services/delivery. The grant program will also consider proposals for projects that are currently being delivered (that have demonstrated promise), but where funding is ceasing.
