

Schedule 3 – Payment Provisions

This Schedule sets out the payment mechanism that DCJ will use to calculate the Service Payment payable to the Service Provider

1. Introduction

This Schedule operates as follows:

- section 3 of this Schedule 3 sets out how the Service Provider will be remunerated in accordance with clause 4 of the Program Level Agreement for the relevant Service(s);
- (b) the Service Provider Declaration is set out in section 4 of this Schedule 3;
- (c) the Service Price List is set out in Appendix A of this Schedule 3; and
- (d) the Service Delivery Volume is set out in Appendix B of this Schedule 3.

2. Definitions

In this Agreement, unless the context requires, all defined terms will have the meanings set out in Schedule 5 – Definitions.

3. Service Payments

- (a) The Payment Arrangements set out in section 3 of this Schedule take effect in accordance with clause 4 of the Program Level Agreement for the relevant Service(s).
- (b) At the commencement of the Term, the Service Payment will consist of the following components:
 - applying only for Foster Care (including Temporary Care Arrangements), Therapeutic Supported Independent Living, Therapeutic Home Based Care, Supported Independent Living, Therapeutic Sibling Option Placement:
 - A. Funding Package Payment, calculated as the Service Provider's Actual Volume multiplied by the quantum of the relevant Funding Package(s), which include:
 - (i) Case Plan Goal Package (Table 2);
 - (ii) Baseline Package¹ (Table 3 with the exception of Therapeutic Sibling Option Placement, which is determined on a case by case basis);
 - (iii) Child Needs Package (Table 4);
 - (iv) Other Specialist Packages (Table 5);
 - ii. applying only for Intensive Therapeutic Transitional Care:
 - A. Baseline Package for each home (Baseline Package (Table 3));
 - iii. applying only for Interim Care:

- A. Baseline Package Payment for each child (Baseline Package (Table 3).
- iv. applying only for Intensive Therapeutic Care Homes and Intensive Therapeutic Care Significant Disability:
 - A. Baseline Package for each child (Baseline Package (Table 3)
 - B. House Package Payment for each home (Table 6)
 - C. Complex Needs on a case-by-case basis, subject to DCJ approval
- v. applying only for Supported Independent Living (over 18) and Therapeutic Supported Independent Living (over 18), effective from 1 January 2024:
 - A. Baseline Package Payment for each person (Baseline Package (Table 3)
- vi. applying only for Interim Care, Intensive Therapeutic Transitional Care and Intensive Therapeutic Care Homes and Intensive Therapeutic Care Significant Disability:
 - A. Placement Establishment Payment (Table 8);
- vii. applying only for Foster Care effective until 30 June 2023:
 - A. Placement Capacity Payment, calculated as the Placement Capacity Payment amount (Table 7) multiplied by the number of Actual Vacancies as at the date on which the Service Payment is to be calculated;
- viii. applying only for Interim Care:
 - A. Interim Care Vacancy Payment, calculated as the Interim Care Vacancy Payment amount (Table 7) multiplied by the number of Actual Vacancies as at the date on which the Service Payment is to be calculated.
- ix. applying for all Services:
 - A. Abatements for Performance Failures, as set out in Appendix A of Schedule 2; and
 - B. Adjustments to reconcile amounts paid in advance of the Service Provider's Actual Volume.

3.1. Funding Package Payment

- (a) The Funding Package Payment is a fixed annual amount per Actual Volumes delivered by the Service Provider. The Funding Package Payment will be paid Quarterly in advance but reconciled at the Payment Reconciliation Date for any over or underpayments that occurred in the previous Financial Year. An adjustment may be required to Quarterly advanced payments due to any Abatements applying.
- (b) The Funding Package Payment is an activity-based payment, calculated based on Actual Volume over the Service Delivery Period. The Funding Package Payment will be reconciled to the Service Delivery Period to ensure the correct level payment is made based on actual Service delivered.
- (c) The Funding Package Payment for Foster Care, Aboriginal Foster Care, Therapeutic Sibling Option Placement, Therapeutic Supported Independent Living.

Supported Independent Living and Therapeutic Home Based Care will be calculated as an aggregation of the individual Child or Young Person service payments (based on the Child or Young Person's circumstances) that together make up the Service Provider's Actual Volume. Individual Child payments will be made up of:

- i. the relevant Case Plan Goal Package, which funds for the achievement of a permanency goal for each child and young person, where the quantum is specified in Table 1 (Appendix A);
- ii. the relevant Baseline Package, which allows for the 'baseline' costs to support a Child or Young Person in a given type of Placement, where the quantum is specified in Table 3 (Appendix A);
- iii. the relevant Child Needs Package, which allows for the provision of Services that address the differing needs of Children and Young People, where the quantum is specified in Table 4 (Appendix A); and
- iv. any Other Specialist Packages which are intended to fund for the provision of other specialist supports required for Children and Young People, by exception, where the quantum is specified in Table 5 (Appendix A).
- (d) With the exception of the Long Term Care Package, funding of the Case Plan Goal Package is time-bound to facilitate the movement of Children and Young People to permanency. In particular, the Restoration/Guardianship/Adoption packages are all funded for a period of up to two years from the date of the final order or the commencement of the Case Plan Goal. At the end of the two year period, funding reduces to the rate of the Long Term Care package, except in exceptional circumstances, where an Extension is approved.
- (e) Children and Young People with the Case Plan Goal Package of Restoration; or Guardianship or Adoption at the start of the Service Start Date will have their Case Plan Goal Packages cease at the earlier of either:
 - i. two years from the start of the Case Plan Goal Package; or
 - ii. the date that DCJ and the Service Provider agree the Case Plan Goal is achieved; or
 - iii. the date that the child or young person's care order, placing them in the Parental Responsibility of the Minister is varied, expires or is rescinded.
- (f) For Children and Young People whose Case Plan Goal is determined after the commencement of the Term, the Case Plan Goal Package will be paid on and from the commencement of the Case Plan Goal. The Case Plan Goal Package payment for each Child or Young Person will be paid with the next payment after the Child or Young Person is placed and Case Plan Goal commences.
- (g) Where the Child or Young Person's Case Plan Goal Package changes as a result of an assessment by DCJ, or change in court order, the Case Plan Goal Package will change to reflect the new Case Plan Goal, and the relevant maximum payment period will commence from that date.
- (h) Where the Child or Young Person has moved to the Service Provider from another Service Provider, the maximum payment period may be extended from that date at DCJ's discretion. The length of the extension will be determined by DCJ, based on DCJ's assessment of the remaining effort required to achieve the Case Plan Goal.
- (i) If a Child or Young Person achieves permanency, a Case Coordination Post Permanency Casework Support package may be paid (if eligible) to prevent the breakdown of permanency outcomes. If eligible, this will be continued for a period

of up to six months after the Case Plan Goal has been achieved for restoration, guardianship and adoptions, subject to approval by DCJ. The Case Coordination - Post Permanency Casework Support package is a stand-alone package.

- (j) If a child or young person is in care, but not in their placement (and their placement has closed), a Case Coordination (Not in Placement) package has been incorporated to support transition of the child or young person to either:
 - i. another authorised placement; or
 - ii. another care arrangement approved by DCJ and/or the Children's Court.

This will be continued for a period of up to six months with a possible extension of up to a further six months, in each case subject to approval by DCJ.

- (k) A case coordination (Not in Placement) package also applies when a Service Provider continues to hold primary case responsibility when a child or young person is placed in an Intensive Therapeutic Transitional Care home, in Interim Care or in a Short Term Emergency Placement. In this case, the Service Provider that continues to hold primary case responsibility will continue to receive the relevant Case Plan Goal Package, Child Needs Package and Other Specialist packages for the child or young person.
- (I) A Case Coordination Restoration Support package applies when a Service Provider restores a child or young person to their parent/s full time in accordance with an approved restoration plan; and the child or young person remains under the Parental Responsibility of the Minister.
- (m) DCJ may, in some circumstances, allocate the Case Coordination package to a different Service Provider to the Service Provider that managed the Child or Young Person's last Foster Care Placement or choose to transfer Case Coordination responsibility to DCJ.
- (n) The applicable Child Needs Package is determined by DCJ. Child Needs Packages may be varied by DCJ if and when the assessed needs of the Child or Young Person change. Differential needs package amounts recognise that Children and Young People will have differing needs, requiring different intensity of support.). Child Needs Package is no longer applicable at the earlier of either:
 - i. the date that DCJ and the Service Provider agree the Case Plan Goal is achieved; or
 - ii. the date that the child or young person's care order, placing them in the Parental Responsibility of the Minister expires or is rescinded.
- (o) Funding of Specialist Packages is subject to eligibility being met. Service Providers will automatically receive payment for Specialist Packages where eligibility is met and demonstrated through ChildStory and written application is not required for:
 - i. Cultural Plan (Aboriginal)
 - ii. CALD
 - iii. Leaving Care
 - iv. 15+ Reconnect
- (p) The Funding Package Payment for Intensive Therapeutic Care Homes and Intensive Therapeutic Care Significant Disability will be calculated as an aggregation of the House Package service payments and the Child Package service payments that together make up the Service Provider's Actual Volume. The Funding Package Payment is made up of:

- i. the relevant Baseline Package (Child Package), which allows for the 'baseline' costs to support a Child or Young Person in a given type of Placement, where the quantum is specified in Table 3 (Appendix A);
- ii. the relevant House Package, which allows for the costs to operate a 2 bedroom or 4 bedroom ITC Home or ITC Significant Disability home, where the quantum is specified in Table 6 (Appendix A). When a two-bed house is vacant, the two-bed House Package payment will not be paid for the vacant house.

3.2. Placement Establishment Payment

- (a) The Service Provider will be funded a Placement Establishment Payment for each new:
 - i. Intensive Therapeutic Transitional Care unit contracted for; or
 - ii. Interim Care home, Intensive Therapeutic Care house or Intensive Therapeutic Care Significant Disability home contracted for, that is over and above Contracted Volume.
- (b) The quantum of the Placement Establishment Payment is specified in Table 9 (Appendix A).
- (c) The Placement Establishment Payment amount will be a one-off payment, paid in recognition of the costs of establishing a new ITTC unit, Interim Care home, ITC home or Intensive Therapeutic Care Significant Disability home. The payment will not apply where a Service Provider moves existing Placements to a new ITTC home, Interim Care home, ITC Home or Intensive Therapeutic Care Significant Disability home, unless at the request of DCJ.

3.3. Placement Capacity Payment

- (a) The Placement Capacity Payment is effective until 30 June 2023. From 1 July 2023, the Placement Capacity Payment will no longer apply.
- (b) The Placement Capacity payment is for Foster Care only.
- (c) The Placement Capacity Payment is paid for Actual Vacancies, where there is no Child or Young Person in care. A Placement Capacity Payment will be paid for each unit of Actual Vacancies, not currently filled with a Placement. Actual Vacancies can occur when:
 - i. Child or Young Person is transitioned out of a Service Provider's care (including through achievement of permanency); or
 - ii. there is insufficient Placement demand.
- (d) The total Placement Capacity Payment will be calculated in advance for each Quarterly Date until 30 June 2023, based on the number of Expected Vacancies for that Quarter. To the extent that Actual Vacancies are filled throughout the Quarter (i.e. Expected Vacancies do not eventuate, or eventuate for a shorter than anticipated period), the Placement Capacity Payment will no longer apply, and will be replaced by the applicable Funding Package Payment for the remaining days of the Quarter. A reconciliation will be undertaken at the Payment Reconciliation Date.

3.4. Interim Care Vacancy Payment

- (a) The Interim Care Vacancy Payment applies only for Interim Care.
- (b) The Interim Care Vacancy Payment covers the cost of maintaining Actual Vacancies, where there is no Child or Young Person in care. An Interim Care Vacancy Payment will be paid for each unit of Actual Vacancies, not currently filled with a Placement. Actual Vacancies can occur when:
 - i. Child or Young Person is transitioned out of a Service Provider's care (including through achievement of permanency); or
 - ii. there is insufficient Placement demand.
- (c) The Interim Care Vacancy Payment will be equal to the Baseline Package for Interim Care listed in Table 6 (Appendix A) for the first 14 calendar days of a placement vacancy, and thereafter will be equal to the amount listed in Table 8 (Appendix A).
- (d) The total Interim Care Vacancy Payment will be calculated in advance for each Quarterly Date, based on the number of Expected Vacancies for that Quarter. To the extent that Actual Vacancies are filled throughout the Quarter (i.e. Expected Vacancies do not eventuate, or eventuate for a shorter than anticipated period), the Interim Care Vacancy Payment will no longer apply, and will be replaced by the applicable Funding Package Payment for the remaining days of the Quarter. A reconciliation will be undertaken at the Payment Reconciliation Date.

3.5. Adoption Legal Work Payment

- (a) This is a fixed payment for legal adoption work undertaken by the Accredited Adoption Service Provider for Children and Young People with a Case Plan Goal of adoption where legal work has been undertaken.
- (b) The payment is triggered at the commencement of the court action and only applies to Accredited Adoption Service Providers. The amount will be paid in the next subsequent quarterly payment. The quantum of the Adoption Legal Work Payment is specified in Table 5 (Appendix A).

3.6. Cultural Plan (Aboriginal) Payment

- (a) In respect of Cultural Plan payments for Aboriginal Children and Young People, the Service Provider will be paid:
 - i. a one-off payment intended for all Aboriginal Children and Young People entering care to:
 - Develop and establish an individual cultural care plan and support participation in cultural activities; and
 - 2) Support comprehensive family finding and genealogy work including family group conferencing and participation of family and kin in establishing genealogy trees and relationship maps; or
 - ii. a support payment in each subsequent financial year to support the review of cultural plans and participation in cultural activities.

The payment is automatically paid based on a Child or Young Persons Aboriginal status in ChildStory. The quantum of the Cultural Care Plan (Aboriginal) payment is specified in Table 5 (Appendix A).

3.6. Aboriginal Transition Support Payment

- (a) The Aboriginal Transition Support Payment is effective from 1 July 2023. Prior to 1 July 2023, the Aboriginal Transition Support Payment does not apply.
- (b) Commencing 1 July 2023, a Service Provider who is an Aboriginal Community Controlled Organisation, will be paid an Aboriginal Transition Support Payment, as specified in Table 10 (Appendix A).
- (c) Payments are made annually in Quarter 1 of each financial year.

3.7. Sustainability Payment

- (a) The Sustainability Payment is effective from 1 July 2023. Prior to 1 July 2023, the Sustainability Payment does not apply.
- (b) The Sustainability Payment is available only for non-Aboriginal Foster Care Service Providers with less than 100 contracted placements.
- (c) The Sustainability Payment is not automatic and will be available on a needs basis approved by DCJ.

3.8. Abatements

- (a) Abatements may apply to the provision of Services based on the Service Provider's KPIs set out in Appendix A of Schedule 2.
- (b) If at any time subsequent to the commencement of the Term, a Performance Failure occurs, DCJ may make Abatements from any Service Payment.
- (c) No reduction in Abatements shall be permitted where the same event causes more than one type of Performance Failure.
- (d) Abatements will be applied at the time DCJ becomes aware of a Performance Failure and the DCJ Representative has received approval to apply that abatement from DCJ's delegated decision maker at the Executive Director level (or equivalent or higher).
- (e) DCJ will be entitled to apply Abatements retrospectively.
- (f) A Service Provider may submit additional information which DCJ may take into consideration when determining whether to apply the relevant Abatement.

Appendix B: Service Delivery Volume

- (a) Appendix B sets out the Service Provider's Maximum Contracted Volumes for Intensive Therapeutic Care Homes, Intensive Therapeutic Care Significant Disability, Intensive Therapeutic Transitional Care, Interim Care and Foster Care Services; and location(s) for Intensive Therapeutic Care Homes, Intensive Therapeutic Care Significant Disability and Interim Care, during the term of the Permanency Support Program.
- (b) Actual Volume in Foster Care means the number of Children and Young People receiving a service from a Service Provider over the Service Delivery Period. For Foster Care, this includes children and young people receiving a case coordination package. Actual Volume in Intensive Therapeutic Care Homes and Intensive Therapeutic Care Significant Disability means the number of 4 bed and 2 bed homes the provider is expected to have available for children and young people.
- (c) Contracted Volumes will not be set for Therapeutic Sibling Option Placements, Therapeutic Supported Independent Living, Therapeutic Home Based Care, Case Coordination or Supported Independent Living. DCJ will formally request Service Providers to provide a number of placements by placement type and location as the need arises for these placement types. These placements will be paid based on actuals.
- (d) The parties acknowledge and agree that the Minimum Contracted Volume and Maximum Contracted Volume set out in this Appendix may be varied by DCJ in accordance with section 7.5 (Variation to increase the Contracted Volume), or section 7.6 (Variation to decrease Contracted Volume) as set out in the Program Level Agreement.
