Adoption agencies

Some adoptions were arranged privately by a solicitor or an adoption agency. In these cases FACS usually only holds very limited information. Detailed social and medical information may be gained by applying directly to the agency that arranged the adoption. Private Adoptions / Solicitor Adoptions

Some adoptions were arranged privately when parties either knew each other, or were advised of each other through a third party. Solicitors, who finalised these adoptions, did not keep records for a long period of time. You will be informed of the name of the solicitor who arranged the adoption if this is known, when you receive your social and medical information.

If the solicitor who arranged the adoption is no longer practicing you can contact the Law Society Registry at the Law Society of NSW who may be able to give you further advice.

Adoption Support Agencies

Post Adoption Resource Centre

The Post Adoption Resource Centre (PARC), managed by The Benevolent Society, is funded by FACS to specifically offer services to people affected by the Adoption Act 2000. PARC provides statewide services that include:

- face to face counselling
- telephone counselling
- information meetings information on searching, on other peoples' experiences of reunions
- entitlements under the Adoption Act 2000
- an intermediary/mediation service
- a network of volunteer clients who can provide informal support
- short term groups focusing on a variety of issues
- a resource centre and library, and
- a quarterly newsletter, 'Branching Out'.

Fees are charged on a sliding scale for PARC's services, although no person will be denied services due to their inability to pay.

The Salvation Army Special Search Service
